LAL Family Partners L.P. ("LALFP") transferred 1,343,846 shares of Class A Common Stock to The 1992 GRAT Remainder Trust f/b/o

(1) Gary M. Lauder (the "GML GRAT Remainder Trust") in exchange for receiving 1,343,846 shares of Class B Common Stock from the GML GRAT Remainder Trust.

(3) LALFP transferred 1,280,456 shares of Class A Common Stock to The 1992 GRAT Remainder Trust f/b/o William P. Lauder (the "WPL GRAT Remainder Trust") in exchange for receiving 1,280,456 shares of Class B Common Stock from the WPL GRAT Remainder Trust.

There is no exercise or conversion price for the Class B Common Stock. Shares of Class B Common Stock may be converted immediately on a one-for-one basis by the holder and are automatically converted into Class A Common Stock on a one-for-one basis

(4) upon transfer to a person or entity that is not a "Permitted Transferee" (as defined in the Issuer's Restated Certificate of Incorporation) or soon after a record date for a meeting of stockholders where the outstanding Class B Common Stock constitutes less than 10% of the outstanding shares of Common Stock of the Issuer.
