On October 14, 2004, Sprint concluded that a non-cash charge for impairment of its long distance network assets would be required to be recorded in its third quarter 2004 financial results under generally accepted accounting principles. On October 19, 2004, Sprint announced that the pre-tax non-cash impairment charge to its long distance assets will be approximately \$3.5 billion.
