- (1) On October 2, 2007, the common stock of Johnson Controls Inc., split 3-for-1, resulting in the reporting person's ownership of 30,614 additional shares of common stock.
- (2) Award of 3,076 stock units was mistakenly reported as shares of Johnson Controls stock in Table I. The award on January 23, 2008, was actually issued as 3,076 phantom stock units in the Directors' Deferred Compensation Plan reported in Table II. This amended report corrects the issuance information.
- (3) The phantom stock units convert to the common stock's cash value on a one-for-one basis.

The Phantom stock units were accrued under the Johnson Controls Directors' Deferred Compensation Plan and are to be settled 100% in cash. The reporting person has the right to transfer the value of the phantom stock account into an alternative investment account within the plan or move out of the plan.

(5) On October 2, 2007, the common stock of Johnson Controls Inc., split 3-for-1, resulting in the reporting person's ownership of 27,655.04 of additional phantom stock units.

(6) Includes 533.914 phantom stock units acquired through the reinvestment of dividends on March 30, June 29 and October 2, 2007, and January 3, 2008, at prices ranging from \$31.54 to \$39.8667 per phantom stock unit.

(7) The Phantom stock units were accrued under the Johnson Controls Directors' Retirement Plan and are to be settled 100% in cash. The reporting person has the right to transfer the value of the phantom stock account into an alternative investment account within the plan or move out of the plan.
