Although discretionary responsibility for the accounts is with NewSouth MKPfd retains responsibility for SEC filings should their cumulative holdings trigger the need for 13G reporting.

Of the 1,222,602 shares being reported, 685 or .003% of the outstanding shares of Common Stock of Oceaneering International, Inc. are managed by NewSouth Capital Management, Inc. through a Smith Barney Fiduciary Services Program whereby accounts are placed with NewSouth for management. Although discretionary responsibility for the accounts is with NewSouth Smith Barney retains responsibility for SEC filings should their cumulative holdings trigger the need for 13G reporting.

Of the 1,222,602 shares being reported, 11,800 or .05% of the outstanding shares of Common Stock of Oceaneering International, Inc. are managed by NewSouth Capital Management, Inc. through a Thomas Weisel Partners LLC Asset Management Consulting Program whereby accounts are placed with NewSouth for management. Although discretionary
