As of December 31, 2018, the Reporting Persons Conestoga Capital Advisors indirectly beneficially owned 2,089,014 shares while the Conestoga Small Cap Fund owned 1,250,110 of the 22,700,991 of the Issuer's Common Stock indirectly beneficially owned by Conestoga Capital Advisors. Such shares of the Issuer's Common Stock were directly beneficially owned by the Accounts. The Conestoga Small Cap Fund beneficially owned more than 5.0% of the Issuer's issued and outstanding Common Stock.

As of December 31, 2018, the Reporting Persons indirectly beneficially owned 9.20% and 5.50% of the Issuer's issued and outstanding Common Stock (based on 22,700,991 shares of the Issuer's Common Stock outstanding as of November 6, 2018 as reported by the Issuer in its Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on November 6, 2018).
