On July 1, 2006 the Board of Directors appointed Christopher Crupi, CA, as director, chief executive officer, chief financial officer and secretary-treasurer of the corporation. Chris was formerly a Vice President at PricewaterhouseCoopers, and is currently President and CFO of Paramount Gold Mining Corp., ( PGDP:OTC), a publicly-traded mining exploration company. Mr. Crupi was issued 3 million shares of one year restricted common stock. Mr. Crupi's annual compensation is to be determined.
