This Current Report on Form 8-K/A amends and supplements the Current Report on Form 8-K of NGL Energy Partners LP, filed with the Securities and Exchange Commission on November 7, 2012 (the **Form 8-K** ), which reported under Item 2.01 the completion of a business combination with Pecos Gathering & Marketing, L.L.C. and its affiliated companies Transwest Leasing, LLC, Blackhawk Gathering, LLC, Midstream Operations, LLC, and Striker Oilfield Services, LLC (collectively, **Pecos** ). This amendment is filed to provide the financial statements of Pecos and the pro forma financial information of NGL Energy Partners LP for such transaction as required by Item 9.01.
