Minera Andes, Inc. ("MAI") holds a 49% interest in Minera Santa Cruz S.A. ("MSC"), an Argentine in operating company. Under the terms of a joint venture agreement, Mauricio Hoschchild & Cia. Ltda acquired a 51% ownership in MSC in 2003. As a result of this change in ownership, MAI began accounts interest in MSC using the equity method in December 2003.

Under the equity method, 49% of MSC's earnings and losses are included in MAI's operations and it in MSC is adjusted by a like amount. This adjustment was not material for 2003 but will most like material for 2004.

MSC is managed and controlled by MHC. MAI has not yet received the audit of MSC because it has no completed. MAI cannot complete its own audit until it receives the MSC audit.
