## **Petrobras announces important discovery of petroleum in the Espirito Santo basin**

---

(Rio de Janeiro, July 11, 2003). PETRÓLEO BRASILEIRO S.A. Petrobras, (BOVESPA: PETR3 / PETR4, NYSE: PBR / PBRA, LATIBEX: XPBR / XPBRA), Brazil's largest oil and gas, petrochemicals and energy company, announces that it has made a new discovery in the State of Espírito Santo, at well 1-ESS -123, in block BES -100, at a water depth of 1.374 meters, about 60 km from the coast and 80km from that state's capital, Vitória.

The preliminary logging confirms the occurrence of 50 meters of oil bearing sandstone at a depth of 3.784 meters. Drilling will continue to a depth of 4.400 meters, with the possibility of new discoveries.

This discovery is specially significant as it represents a substantial new find outside the Campos Basin.
