(2) A clerical error occurred in calculating the additional RSUs resulting from the dividend payment on October 15, 2013. This error appeared in the Form 4 filed on October 17, 2013. Instead of using \$35.70, the closing price on that dividend payment date, \$35.10 was used in the calculation described in Footnote 1 therein, resulting in over-reporting the additional RSU grant by 4 shares.
