- (1) On December 17, 2012 the Issuer granted the Reporting Person a Restricted Stock Award of 3,133 restricted shares of First Midwest Bancorp, Inc. common stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On December 17, 2014, 1,567 shares of the originally granted restricted stock award vested, of which 507 shares were withheld in order to satisfy the Reporting Person's tax withholding obligations.
- (2) Between March 13, 2014 and December 18, 2014 the Reporting Person acquired 5 shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan pursuant to the Dividend Reinvestment feature of the Plan; 266 shares pursuant to bi-weekly payroll deductions and 233 shares were received from the employer match.
