(1) On February 20, 2013 the Issuer granted the Reporting Person a restricted stock award of 22,260 restricted shares of First Midwest Bancorp, Inc. common stock under the Amended and Restated First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 20, 2015, 11,130 shares of the originally granted restricted stock award vested, of which 5,148 shares were withheld in order to satisfy the Reporting Person's tax withholding obligations.

(2) On February 22, 2012 the Issuer granted the Reporting Person a restricted stock award of 40,185 restricted shares of First Midwest Bancorp, Inc. common stock under the Amended and Restated First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 22, 2015, the remaining 20,092 shares of the originally granted restricted stock award vested, of which 9,183 shares were withheld in order to satisfy the Reporting Person's tax withholding obligations.
