- (1) On February 17, 2016 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 9,812 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 17, 2019, the remaining 4,906 shares of the originally granted RSAs vested, of which 1,646 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
- (2) Between March 8, 2018 and February 6, 2019, the Reporting Person acquired the following shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan (the "Plan"): (a) 389 shares pursuant to match contributions from the Company; (b) 442 shares pursuant to payroll contributions; (c) 133 shares were received under the dividend reinvestment feature of the Plan; and (d) 6 shares were sold to pay administrative fees. This information is based on a Plan statement dated February 6, 2019.
