Arledge and Fatt as an audit committee financial expert does not make either an expert for any purpose, impose any duties, obligations or liability on either of them that are greater than those imposed on members of the audit committee and board of directors who do not carry this designation or affect the duties, obligations or liability of any other member of the audit committee.

PricewaterhouseCoopers LLP (or a predecessor firm, Price Waterhouse) (PwC) have been the auditors of the Registrant since 1992.

On October 30, 2003, the Registrant's Audit, Finance & Risk Committee adopted a policy that requires pre-approval by the Audit, Finance & Risk Committee of any services to be provided by the auditors, whether audit or non-audit services. During the years ended December 31, 2003 and 2004, all audit and non-audit services were pre-approved by the Audit, Finance & Risk Committee.

Tax fees are primarily for tax compliance and tax advisory services. All other fees are primarily for advisory services.
