The revenues for the three months ended March 31, 2002 decreased to \$2.5 million from \$4.7 million for the three months ended March 31, 2001.

The decrease in advertising revenues was primarily attributable to a significant industry-wide decrease in the advertising market and to a dramatic reduction in the company's sales force as part of the August 2001 cost reduction and restructuring initiatives, which included closing of www.theglobe.com website business.
