 6,400 Restricted Stock Units (Common Stock equivalents) were granted pursuant to the WD-40 Company 2007 Stock Incentive Plan. The Restricted Stock Units (RSUs) will be settled solely with Issuer Common Stock upon an annual vesting schedule as provided for in the Award Agreement for the RSUs as follows: 2,176 shares not later than 11/15/2010, 2,112 shares not later than 11/15/2011, and 2,112 shares not later than 11/15/2012.
