On May 15, 2018, WhiteHorse Finance Credit I, LLC ("WhiteHorse Credit"), a wholly owned subsidiary of WhiteHorse Finance, Inc. (the "Company"), JPMorgan Chase Bank, National Association, as administrative agent and lender, the financial providers thereto, and the Company, as portfolio manager, amended and restated the terms of the second amended and restated loan agreement by and among the aforementioned parties (as amended and restated, the "Third Amended and Restated Loan Agreement"). Among other things, the Third Amended and Restated Loan Agreement permits the financing of certain assets of a wholly owned subsidiary of WhiteHorse Credit.
