IT RECEIVED A LAWSUIT REQUESTING CERTIFICATION AS A CLASS ACTION

Rosh Ha'ayin, Israel, August 27, 2009 **Partner Communications Company Ltd. (Partner or the Company) (NASDAQ and TASE: PTNR), a leading Israeli mobile communications operator,** announced today that it was served with a lawsuit requesting certification as a class action, filed against Partner in the Central District Court (Petach-Tikva).

The claim alleges that Partner misled its subscribers by wrongfully not disclosing material terms of sale in a certain marketing campaign that it carried out.

If the lawsuit is certified as a class action, the total amount of claim against Partner is estimated by the Plaintiffs to be approximately NIS 982,000,000.

Partner is reviewing and assessing the lawsuit and at this preliminary stage is unable to evaluate the probability of success of the lawsuit or the range of potential exposure, if any, with any degree of certainty.
