(SSF3, Cayman and SSPE will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.

(b) Percent of Class: Messrs. Marx and Greenhouse beneficially own 16.8% of the shares outstanding. Cayman owns 2.0% of the outstanding shares, SSPE owns 7.4% of the outstanding shares and SSF3 owns 7.9% of the outstanding shares.
