(1) Settlement of Restricted Stock Units exempt under Rule 16b-3. Settlement of units was made on January 2, 2018 with 18,371 shares withheld for taxes, resulting in the delivery of 22,772 shares to Reporting Person.

(2) Each unit represents a right to receive one share of Bemis Common Stock upon vesting.

(3) Grant of Restricted Stock Unit exempt under Rule 16b-3. The units will vest on December 31, 2020 and will be settled in the form of Bemis Common Stock as soon as administratively possible thereafter.

The units will be settled in the form of Bemis Common Stock if certain performance targets are achieved for the performance period ending December 31, 2020. Settlement is expected to occur following Compensation Committee certification of the performance targets, which is anticipated to occur in February 2021.
