- (1) Non-Qualified Stock Option: Exercisable Date - Option vesting is over a four year period, vesting 25% on each anniversary of the grant date, contingent upon continued service to Invitrogen.
- (2) Restricted Stock Unit: Exercisable Date - Options are exercisable upon vesting after a three year period contingent upon continued service to the company. Expiration Date - Once vested, Restricted Share Units do not expire. They can be converted into shares of Invitrogen stock on the vest date.
- (3) Performance Shares: Exercisable Date - Shares are exercisable based on a target stock price. Expiration Date - Unvested Performance Shares expire on November 30, 2008.
