- (1) 401(k) Plan: This amount includes shares and dividends acquired during the fiscal year pursuant to the H.B. Fuller Company Thrift Plan. Amended and Restated 2000 Stock Incentive Plan: 79,853 restricted shares were awarded pursuant to H.B. Fuller Company's Amended and Restated 2000 Stock Incentive Plan. Amount includes 4,852 restricted shares that vest effective April 5, 2009; 16,660 restricted shares that vest effective December 4, 2009; 20,206 restricted shares that vest effective December 6, 2010; and 38,135 restricted shares that vest effective December 4, 2011. Total amount also includes restricted shares acquired pursuant to a dividend accrual feature of the Amended and Restated 2000 Stock Incentive Plan.
- (3) 2000 Stock Incentive Plan: This option vested in four equal annual installments beginning on June 27, 2003.
- (4) 2000 Stock Incentive Plan: This option vested in four equal annual installments beginning on December 9, 2003.
- (5) 2000 Stock Incentive Plan: This option vested in four equal annual installments beginning on December 3, 2004.
- (6) 2000 Stock Incentive Plan: This option vested in four equal annual installments beginning on December 2, 2005.
