The DSUs credited to the director's account consist of (i) 3,715 DSUs for retainer fees that are required to be paid to the director in the form of DSUs and (ii) 4,063 DSUs for retainer fees that the director has elected to be paid in the form of DSUs. The number of DSUs acquired by the director was based on the weighted-average price at which the Company's restricted voting shares traded on the Toronto Stock Exchange on July 28, 2011 and July 29, 2011 (the two trading days prior to the acquisition date), which was \$2.15 (as converted from C\$2.05 using the average of the closing rates of exchange from Reuters on July 28 and July 29, 2011).
