Also includes 4,950 RSUs voluntarily deferred by Mr. Derechin from his annual discretionary bonus, plus 1,237 RSUs granted to Mr. Derechin as a company match on his voluntary bonus deferral. These RSUs generally will be delivered on the third anniversary of grant. Also includes 24,870 RSUs that vest one-fifth ratably on each of January 27, 2007, 2008, 2009, 2010 and 2011.
