Item 3.02 Unregistered Sales of Equity Securities

On March 4, 2015, the Registrant nullified a previously disclosed 528,229 share authorization to RLS Premiere Financial LLC ("RLS ") at the request of the investor.

On March 6, 2015, and March 10, 2015, the Registrant accepted two conversion notices from KBM Worldwide, Inc. ("KBM ") to partially satisfy a \$98,500 Convertible Promissory Note Agreement ("the KBM Note") dated August 6, 2014 with KBM. An aggregate of 957,107 shares were issued to satisfy \$2,345 of the outstanding principal in accordance with the terms of the KBM Note. As of the date of this report the remaining amount currently outstanding on the KBM Note is \$91,890.

On March 11, 2015, the Registrant accepted a conversion notice from Tangiers Investors LP, ("Tangiers") to partially satisfy a \$750,000 Convertible Promissory Note Agreement ("the Note") dated October 2, 2012 with Tangiers. 1,399,579 shares were issued to satisfy \$3,331 of the outstanding principal and interest in accordance with the terms of the Note, as amended on December 5, 2014. As of the date of this report the remaining amount currently outstanding on the Note, including accrued interest, is now \$459,749.

KBM and Tangiers are each an "accredited investor" as defined under Rule 501 of Regulation D. The Company believes that these transactions are exempt from registration with the Securities and Exchange Commission pursuant to Section 4(2) of the Securities Act of 1933, as amended.

The above described executed Notes are attached hereto and incorporated by reference as Exhibits 10.1 through 10.3.

As of the date of this report the Registrant has 15,395,253 shares of its common stock issued and outstanding and 15,237,143 shares in the public float.
