Item 2.02. Results of Operations and Financial Condition.

On January 23, 2007, Albemarle Corporation (the Company) issued a press release regarding its earnings for the fourth quarter and twelve months ended December 31, 2006. A copy of this release is being furnished as Exhibit 99.1 hereto and incorporated herein by reference. In addition, on January 24, 2007, the Company will hold a teleconference for analysts and media to discuss results for the fourth quarter and year ended December 31, 2006. The teleconference will be webcast on the Company s website a<u>t www.albemarle.com</u>.

The press release attached as Exhibit 99.1 includes net income and related per share amounts excluding the charge that relates to the divestiture of the Thann, France facility and certain other special items. Net income excluding the Thann charge and other special items is a financial measure that is not required by, or presented in accordance with, accounting principles generally accepted in the United States (GAAP). The Company has reported net income excluding the Thann charge and other special items because management believes that this financial measure is more reflective of the Company s operations, provides transparency to investors and enables period-to-period comparability of financial performance. Net income excluding the Thann charge and other special items should not be considered as an alternative to net income determined in accordance with GAAP. The Company has included in the press release a reconciliation of net income excluding the Thann charge and other special items, a non-GAAP financial measure, to net income, the most directly comparable financial measure calculated and reported in accordance with GAAP.

The press release attached as Exhibit 99.1 also includes net debt, which is a financial measure that is not required by, or presented in accordance with, GAAP. The Company has presented net debt because management believes that net debt is helpful in analyzing leverage and uses it as a performance measure. Net debt should not be considered as an alternative to total debt determined in accordance with GAAP. The Company has included in the press release a reconciliation of net debt, a non-GAAP financial measure, to total debt, the most directly comparable financial measure calculated and reported in accordance with GAAP.
