Item 1.01. Entry into a Material Definitive Agreement.

On November 30, 2007, Citadel Broadcasting Corporation (Citadel) entered into an indemnification agreement (the Indemnification Agreement) with Thomas Reifenhiser in connection with his election to Citadel 's Board of Directors (the Board). The Indemnification Agreement provides for Citadel to indemnify Mr. Reifenhiser for certain expenses and liabilities that may arise in connection with his service as a director, as described in such Indemnification Agreement. A copy of the Indemnification Agreement is filed herewith as Exhibit 10.1.

Item 5.02. Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

(d) As of November 30, 2007, the Board elected Thomas Reifenhiser to the Board to serve as a Class II director to fill the vacancy created by Katherine Brown 's resignation. Mr. Reifenhiser 's term will expire on the date of Citadel 's annual meeting of shareholders in 2008 or when his successor has been elected and has qualified. Citadel issued a press release announcing Mr. Reifenhiser 's election to the Board on December 4, 2007, which is filed herewith as Exhibit 99.1.

Mr. Reifenhiser will be compensated for his service as a director in accordance with Citadel 's standard compensation arrangements for directors who are not employees of Citadel or general partners of Forstmann Little & Co. as described in the Current Report on Form 8-K that Citadel filed with the Securities and Exchange Commission on May 26, 2006.
