This Issuer Tender Offer Statement on Schedule TO relates to the offer by The Swiss Helvetia Fund Inc., a closed-end management investment company organized under the laws of the state of Delaware (the Fund ), to purchase up to 4,579,480 of its issued and outstanding shares of common stock, par value \$0.001 per share, at a price equal to 95% of the net asset value ( NAV ) per share, determined as of the close of the regular trading session of the New York Stock Exchange (the NYSE ), on the business day immediately following the day the offer expires, to the seller in cash, less any applicable withholding taxes and without interest. The Fund s offer is being made upon the terms and subject to the conditions set forth in the Offer to Purchase, dated January 13, 2014, and the related Letter of Transmittal, copies of which are attached to this Schedule TO as Exhibits (a)(1)(i) and (a)(1)(ii), respectively (which together, as amended or supplemented from time to time, constitute the Offer ). This Issuer Tender Offer Statement on Schedule TO is intended to satisfy the reporting requirements of Rule 13e-4(c)(2) under the Securities Exchange Act of 1934, as amended.
