**Prepayment of bank debts, renegotiation and new financing**

Rio de Janeiro, November 6, 2017 Petróleo Brasileiro S.A. Petrobras reports that it has executed debt prepayment (US\$ 1.28 billion), renegotiation of existing debt (US\$ 1.6 billion) and new financing operation (US\$ 300 million), according to the tables below.
