As sole trustee of the Trust, Mr. Vendrow may be deemed to hold voting and dispositive power with



respect to the shares held by the Trust. Mr. Vendrow serves as custodian of his minor children's accounts and may be deemed to hold voting and dispositive power with respect to the shares in such accounts. The 213,580 shares underlying the options that are exercisable within 60 days of December 31, 2018 and the 6,742 shares underlying restricted stock units subject to a restricted stock agreement that are scheduled to vest within 60 days after December 31, 2018 are deemed outstanding pursuant to SEC Rule 13d-3(d)(1)(i).
