(1) Each performance-based restricted stock unit represents a contingent right to receive one share of Electronic Arts common stock.

(2) Represents the maximum number of shares of Electronic Arts common stock that may be awarded upon the achievement of certain performance targets.

Performance-based restricted stock units will vest subject to the terms and conditions of the grant agreement evidencing the award and the Company's 2000 Equity Incentive Plan. The performance terms are described in the Form 8-K filed with the SEC on June 1, 2011, as well as the accompanying form of grant agreement.

(4) Each restricted stock unit represents a contingent right to receive one share of Electronic Arts common stock.

(5) Restricted stock units vest as to one-third on May 16, 2012; then vest as to an additional one-third on May 16, 2013, and then vest as to the remaining one-third on May 16, 2014.
