- (1) This total reflects shares received due to a 2:1 stock split on June 18, 2007.
- (2) As of July 6, 2007, I have 10.1609 equivalent shares of stock in Questar's Employee Investment Plan. The number of equivalent shares will fluctuate as Questar's stock price changes; this fluctuation does not reflect any transactions that should be reported.
- (3) Phantom stock units will be converted to cash per my elections on or within 5 years of my termination of employment (subject to 6-month delay if necessary to comply with IRC 409A), or upon my death or Disability.
- (4) I also receive phantom stock units as a result of my participation in an excess benefit plan. This total includes 559.4096 units in such plan in addition to units held through my account balance in a deferred compensation plan. I also receive dividends.
- (5) As previously reported, the options granted in January of 2005 vest in four equal annual installments beginning six months after grant. My total reported includes installments of this option that vested since the date of the last report.
