(1) As previously reported, in connection with the merger consummated on April 5, 2006, 30,000 options rolled over and modified into 27,568 options to acquire the Company's Class A-1 Common Stock at an exercise price of \$9.25. In connection with the extraordinary dividend payable and paid on May 14, 2007, these options were further modified into 34,771 options to acquire the shares of the Company's Class A-1 Common Stock at an exercise price of \$7.34.
