An initial grant of 50,000 shares reported on a Form 4 dated May 7, 2010 contained performance-based vesting. That grant vested on

(1) November 6, 2012 at 85.3%, or 42,650 shares, based on the achievement of the performance criteria. This transaction represents the forfeiture of the remaining 14.7%, or 7,350 shares, that did not vest.
