- (1) two-year period beginning in 2015, and upon vesting, will be payable in Company stock (each RSU representing one share of Company stock). Additional terms apply in the event of the holder's termination, death or retirement.
 - (2) Represents a grant of RSUs granted by the Company's Compensation Committee on March 4, 2014. The RSUs will vest on March 4, 2017. Additional terms apply in the event of the holder's termination, death, disability or retirement.

They will vest in equal amounts over three years and will expire ten years after the grant date.
