This Amendment No. 2 is being filed jointly by the Reporting Persons and amends the Schedule 13G initially filed by the Reporting Persons with the Securities and Exchange Commission (the "SEC") on December 20, 2017, as amended by Amendment No. 1 thereto filed by the Reporting Persons with the SEC on February 13, 2018 (the "Schedule 13G").

Except as set forth below, all Items of the Schedule 13G remain unchanged. All capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Schedule 13G.

As of close of business on December 31, 2018, each of the Reporting Persons may have been deemed to have beneficial ownership of 1,442,067 shares of Common Stock, which consisted of (i) 400 shares of Common Stock held by Intracoastal and (ii) 1,441,667 shares of Common Stock issuable upon exercise of the Intracoastal Warrant, and all such shares of Common Stock in the aggregate represented beneficial ownership of approximately 4.4% of the Common Stock, based on (1) 31,057,215 shares of Common Stock outstanding on October 26, 2018 as reported by the Issuer, plus (2) 1,441,667 shares of Common Stock issuable upon exercise of the Intracoastal Warrant.
