- On May 16, 2006, the reporting person was granted an option to purchase 4,000 shares of common stock at an exercise price of \$20.76. The performance criteria for 2007 was met, however, years 2008, 2009, 2010 and 2011 were not met. The number of options outstanding and the exercise price were adjusted to reflect the stock dividends that were issued on October 10, 2009, January 10, 2010, April 10, 2010 and July 10, 2010.
