**GOL Announces Traffic Statistics for September 2008**

**São Paulo, October 7, 2008** - GOL Linhas Aéreas Inteligentes S.A. (NYSE: GOL and Bovespa: GOLL4) today released preliminary passenger statistics for the month of September 2008. Consolidated domestic passenger traffic (RPK) for September 2008 increased 0.1% and capacity (ASK) increased 9.6% year-over-year (vs. September 2007). Domestic consolidated load factor for the month was 57% and international consolidated load factor was 60%. GOL's total system load factor for the month of September was 57%.
