 - (4) Shares represent one-tenth of total grant, which grant vests ratably over a ten year period beginning July 1, 2013, pursuant to the terms of the Services Agreement, by and between the Company and Fields Management. Price of shares represents fair market value of shares on the date of original issuance, or July 1, 2013.
 - (5) Shares were issued in lieu of cash compensation at a 15% discount to fair market value, pursuant to the Company's Employee Stock Purchase Plan.
