The Original Filing incorrectly reported that effective as of October 6, 2017 (i) Kristine Ault resigned from the Company’s board of directors (the “Board”), (ii) Jeff Bentz was appointed to the Board, and (iii) William Horne was appointed as the Company’s Chief Financial Officer. These actions were never taken by the Company. This Amendment No. 1 is being filed to correct the Original Filing by deleting reference to those actions.

The Company’s current Board consists of the following members: Amos Kohn, Milton “Todd” Ault, III, Kristine Ault, Robert O. Smith, William Horne and Moti Rosenberg. The Company’s current Chief Executive Officer and Interim Chief Financial Officer is Amos Kohn.
