## Explanation of Responses:

(1) The reporting person received a total of 32,318 shares of Common Stock of the Issuer pursuant to the vesting provisions in the award of restricted stock units. A total of 13,558 shares were surrendered to satisfy tax obligations of the reporting person, resulting in the issuance of a total of 18,760 net shares of Common Stock.

(2) On August 26, 2013, the common stock of Dean Foods Company was adjusted to reflect a 1-for-2 reverse stock split. This line item reports the number of shares beneficially owned by the reporting person after adjustment for the reverse stock split, including the reporting person's receipt of cash in lieu of fractional shares.

(3) These restricted stock units have been adjusted (a) to preserve the intrinsic value of awards existing prior to the spin-off of a portion of the Issuer's ownership interest in The WhiteWave Foods Company on May 23, 2013; and (b) to reflect the reverse stock split on August 26, 2013.

(4) On November 15, 2012, the reporting person received an award of restricted stock units, which is the right to receive shares of Common Stock of the Issuer in the future, subject to the terms and conditions of the award agreement. The units vest annually, on a pro rata basis, over a three year period beginning on the first anniversary of the grant date.
