(1) The reporting person received a total of 8,116 shares of Common Stock of the Issuer pursuant to the vesting provisions in the award of restricted stock units. A total of 2,224 shares were surrendered to satisfy tax obligations of the reporting person, resulting in the issuance of a total of 5,892 net shares of Common Stock.

(2) The reporting person received a total of 13,332 shares of Common Stock of the Issuer pursuant to the vesting provisions in the award of restricted stock units. A total of 3,333 shares were surrendered to satisfy tax obligations of the reporting person, resulting in the issuance of a total of 9,999 net shares of Common Stock.

(4) The reporting person has received an award of restricted stock units, which is the right to receive shares of Common Stock of the Issuer in the future, subject to the terms and conditions of the award agreement. The restricted stock units vest annually, on a pro rata basis, over a three year period beginning on the first anniversary date of the grant.
