- (1) On May 16, 2007 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 5,413 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest in two equal annual installments on the first and second anniversary of the date of grant. On May 18, 2009, 2,706 shares of the originally granted RSAs vested, of which 797 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
- (2) Between July 19, 2008 and May 20, 2009 the Reporting Person acquired 863 shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Dividend Reinvestment Plan. The aggregate information reported in this line item includes such shares as reported in a plan statement dated April 14, 2009.
