On December 18, 2007 and November 6, 2008, the reporting person received two separate grants of Restricted Stock Units ("RSUs") that each represent a contingent right to receive one share of the Company's common stock. The RSUs were granted pursuant to the 2004 (1) Stock Incentive Plan and previously reported as acquired on Table I on a Form 4 and Form 4/A dated December 18, 2007 and November 10, 2008, respectively. On June 18, 2009, in accordance with the terms of the RSU agreement, 1/8 of the shares vested and the Company withheld an equivalent amount of RSUs at fair market value to pay the minimum tax withholding requirements for the reporting person.
