On January 16, 2008, SAP AG, a stock corporation organized under the laws of the Federal Republic of Germany ( SAP ), issued a press release announcing next steps in its successful acquisition of Business Objects S.A., a *société anonyme* organized under the laws of the Republic of France ( Business Objects ).
