As of February 13, 2007, Select and Select Offshore are the beneficial owners of 3,540,575 shares of Common Stock of First Republic Bank ("Common Stock"), for a total beneficial ownership of 11.46% of the outstanding shares of Common Stock. As the President and controlling shareholder of Select and the Manager of Select Offshore, Loening has the power to vote and to direct the voting of and the power to dispose and direct the disposition of the shares of Common Stock owned by Select and Select Offshore.
