NAME OF ISSUER

The name of the issuer is MFS Intermediate High Income Fund (the "Company").

Item 1(b). ADDRESS OF ISSUER'S PRINCIPAL EXECUTIVE OFFICES

Item 2(a). NAME OF PERSON FILING

This statement is being jointly filed by Saba Capital Management, L.P., a Delaware limited partnership ("Saba Capital") and Mr. Boaz R. Weinstein (together, the "Reporting Persons") with respect to the ownership of the Common Shares by Saba Capital Master Fund Ltd. ("SCMF"), Saba Capital Master Fund II, Ltd. ("SCMF II") and Saba Capital Leveraged Master Fund Ltd. ("SCLMF").²

The Reporting Persons have entered into a Joint Filing Agreement, dated August 15, 2014, a copy of which is filed with this Schedule 13G as Exhibit 1, pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k)(1) under the Act.

Any disclosures herein with respect to persons other than the Reporting Persons are made on information and belief after making inquiry to the appropriate party.

The filing of this statement should not be construed as an admission that any of the forgoing persons or the Reporting Persons is, for the purposes of Section 13 of the Act, the beneficial owner of the Common Shares reported herein.

Weinstein is a member of Management and has voting and investment power with respect to the securities held by SCMF, SCMF II and SCLMF and may be deemed to be a beneficial owner of the securities held by SCMF, SCMF II and SCLMF.
