The reporting person named herein (the Reporting Person ) became a greater than 5% beneficial owner of the common stock, par value \$0.001 per share (the Common Stock ) of Biolase Technology, Inc., a Delaware corporation (the Issuer ) on the event date identified on the cover page to this Schedule 13D (the Event Date ). As of the Event Date, the Reporting Person beneficially owned 1,582,150 shares of the Issuer s Common Stock (which constituted approximately 6% of the 24, 244,201 shares of Common Stock outstanding as reported in the Issuer s Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on May 9, 2009 and had (a) sole voting and sole dispositive power with respect to 1,582,150 shares of Issuer s Common Stock and (b) shared voting and shared dispositive power with respect to no shares of the Issuer s Common Stock. Subsequent to such date, the Reporting Person did not acquire additional shares of the Issuer s Common Stock. The amounts reported in this Schedule 13D reflect the Reporting Person s beneficial ownership of the Issuer s Common Stock as of the filing date of this Schedule 13D (the Filing Date ).

**Item 1. Security and Issuer.**

This Schedule 13D is being filed to report the Reporting Person s beneficial ownership of the Issuer s Common Stock as of the Event Date and the Filing Date. The principal executive offices of the Issuer are located at 4 Crowell, Irvine, California 92618.

**Item 2. Identity and Background.**

This Schedule 13D is being filed by Buenavista Market Inc., a Panama corporation, which is solely in the making of investments for its own account. The sole beneficial owner of the Reporting Person is GianFrancesco Moscatelli, a non-U.S. person, whose mailing address for the purpose of this Report is Via Generoso 2, 6900 Lugano, Switzerland. During the last five years, neither the Reporting Person nor Mr. Moscatelli has (a) been

convicted in a criminal proceeding (excluding possible traffic violations or similar misdemeanors), or (b) been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such a proceeding was or is subject to a judgment, decree, or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

Item 3. Source and Amount of Funds or Other Consideration.

As of the Filing Date, the Reporting Person beneficially owns 1,582,150 shares of Common Stock of Issuer which were acquired either in the Open Market or private purchases from the prior owners thereof with investment funds of the Reporting Person and not from borrowed funds or funds from other sources.

Item 4. Purpose of Transaction.

Neither the Reporting Person nor Mr. Moscatelli as the beneficial owner of the Reporting Person has served as an Officer, Director, or Employee of the Issuer at any time, nor is there any present intention for either to serve in any such capacity in the future.

The Reporting Person is concerned with the present composition of the Board of Directors of the Issuer as well as the results of its past operations and intends to evaluate its investment in the Issuer as well as the composition of the Board of Directors and other factors which may effect future operations and results thereof of the Issuer.

Item 5. Interest in Securities of Issuer - Subparagraph (c).

Of the total of 1,582,150 shares of Issuer owned by the Reporting Person, 1,092,150 shares have been owned for periods in excess of 180 days prior to the date of this Report and were purchased in the Open Market. 490,000 shares were purchased as of the date of this Report in a private transaction between the Reporting Person and Societe Generale of Lausanne, Switzerland at a price of \$1.60 per share.
