Northwestern Mutual may be deemed to be the indirect beneficial owner of the balance of such shares as follows: (i) 37,000 shares are owned by the Index 500 Stock Portfolio and 28,100 shares are owned by the Balanced Portfolio of Northwestern Mutual Series Fund, Inc. ( Series Fund ), an affiliate of Northwestern Mutual and a registered investment company; (ii) 3,500 shares are owned by the Index 500 Stock Fund of Mason Street Funds, Inc. ( Mason Street Funds ), an affiliate of Northwestern Mutual and a registered investment company; and (iii) 6,297,990 shares are owned by Lydell, Inc. ( Lydell ), an indirect, wholly owned subsidiary of Northwestern Mutual.

Northwestern Investment Management Company, LLC, a wholly owned company of Northwestern Mutual, serves as an investment advisor to Northwestern Mutual (with respect to the 7,688,456 shares it directly owns and the 6,297,990 shares owned by Lydell) and therefore shares voting and investment power with respect to those shares. Northwestern Investment Management Company, LLC's principal place of business is 720 East Wisconsin Avenue, Milwaukee, Wisconsin, 53202. It is organized under Delaware law.
