As of March 18, 2019, Tonga Partners, LP, Cuttyhunk II Fund, Tristan Partners, LP, Tristan Offshore Fund, Ltd. and sundry separately managed accounts (collectively the "Cannell Investment Vehicles") owned in the aggregate 2,651,736 shares of the common stock of the common stock of I.D.Systems, Inc.
